#### CONSENT TO THE PROCESSING OF PERSONAL DATA OF NATURAL PERSON

## I. In which scope will be my personal data processed by the controller?

## II. For which purpose will be my personal data processed by the controller?

## IV. How long will controller process my personal data?

## V. How and when can I withdraw this consent to personal data processing?

This Your volunteer giving consent to processing of personal data could be withdrawn at any time and free of charge, namely by sending an e-mail to address: <a href="Modes to address">GDPR@itczlin.cz</a>. By the withdrawing is not injured rule of law of processing outgoing the consent, which has been given before its withdrawing. Withdrawing of the consent also does not have any impact on processing of personal data, which are processed by the controller based on other legal basis, than it is consent (i.e. especially if the processing is necessary for execution of the contract, legal duty or from other reasons stated in valid legal regulations).

## VI. Who will have approach to my personal data?

The controller will have the approach to Your personal data, and eventually also third persons – processors, who provide suitable guarantees and their processing meets the requirements according to the valid legal regulations and ensures proper protection of Your rights. Processors will have the approach to these data only for extent and as long as it is necessary.

## VII. How can I contact the controller?

## VIII. What are my rights in connection with protection of my personal data?

In relation to Your personal data You have the following rights:

- c) the right to require restriction of processing;

- d) the right to take objections or complain to processing in specific cases;
- e) the right to require data delegation;
- f) the right for approach to personal data;
- g) the right to be informed on infringement of personal data protection in specific cases;
- h) the right for erasure of personal data (the right to be "forgotten") in specific cases; and
- i) the other rights given in appropriate legal regulations.

# IX. Am I obliged to provide my personal data? What will happen, if I do not provide my personal data?

You provide Your personal data quite volunteer. You are not obliged to provide them. In case that you do not provide Your personal data, any sanction threatens to you.

## X. How are my personal data protected?

All your personal data, which you provide to the controller, are protected by standard procedures and technologies. However it is not objectively to ensure the safety of Your personal data. Therefore it is not even possible to ensure 100% that the third person cannot take the approach to provided personal data, they could not be copied, published, changed or destroyed with breaking through security provisions of the controller. Within this context the controller nevertheless ensures by the regular control, if the system does not contain weak point and it has not been left open to attack and uses such security provision, which are able to reasonably require from the controller not to happen the unauthorized approach to provided personal data, and which provides sufficient protection in consideration of current status of technologies. Taken security provisions are regularly updated. However each data subject is responsible for maintenance of its unique password and other data on eventual accounts in secrecy/confidentiality and for permanent control over the approach to its account.
